Purpose:

Pursuant to the Municipal Government Act, Section 315, the Town of Wolfville hereby by policy closes Park Street, a public street within the Town of Wolfville.

Policy Statement:

- 1. Council does hereby close to public use Park Street, a street located within the Town of Wolfville between Westwood Avenue and University Avenue.
- 2. The street that is hereby closed to public use pursuant to Section 1 of this policy is all that lot of land situate, lying and being between the easterly sideline of Westwood Avenue and the westerly sideline of University Avenue, in the Town of Wolfville aforesaid, bounded and described as follows:

BEGINNING: at a point on the East sideline of Westwood Avenue at

the northwesterly boundary of lands of M.L.Wallace being 660.9 feet southerly from a concrete pier set on the easterly sideline of Westwood Avenue and the South sideline of Park Street

sideline of Westwood Avenue and the South sideline of Park Stree

of Park Street;

THENCE South 82 degrees 05 `East along the northerly boundary of

lands of M.L. Wallace and lands of Governors of Acadia University a distance of 355.8 feet to the westerly sideline of

University Avenue;

THENCE:

North 9 degrees 31 `East along the westerly sideline of University

Avenue a distance of 50 feet to other lands of Governors of

Acadia University;

THENCE:

North 82 degrees 5 `West along other lands of Governors of

Acadia University a distance of 355.8 feet to the easterly sideline of

Westwood Avenue;

THENCE:

South 10 degrees 12 'West along the easterly sideline of

Westwood Avenue 50.0 feet more or less to the place of beginning.

BEING AND INTENDED TO BE: the same lands as shown on a plan prepared by Hiltz and Seamone Company Limited dated January 26, 1968 as plan No 1181-1 and marked Acadia University to Town of

3. Prior to approval of this Policy, Council shall give notice of its intent to close the street by advertisement in a newspaper circulating in the Town, setting out the time and place of a public hearing at which those in favour or opposed to the street closing will be heard.
